ON-LINE ADMISSION TO TWO YEAR B.ED. COURSE IN NON- GOVT COLLEGES OF EDUCATION AND BHADERWAH CAMPUS, UNIVESITY OF JAMMU (2019-21)

Eligibility: - Admission shall be open to those candidates who have passed their Bachelor's Degree Examination (10+2+3 pattern) with 45% aggregate marks (40% for SC/ST candidates) in the Faculties of Arts, Science, Social Sciences, Commerce or faculty of Music and Fine Arts from the University of Jammu or an examination of any other University recognized as equivalent thereto or Bachelor's Degree examination of 4 year duration from a recognized University.

["Bachelor Degree" means bachelor's degree in the faculties of Arts, Science, Social Sciences or Commerce (under 10+2+3 pattern) of the University of Jammu or Bachelor's Degree in the Faculty of Music & Fine Arts of the University of Jammu or a Degree of any other University recognized as equivalent thereto or Bachelor's Degree of 4-year duration in the faculty of Agriculture of a recognized University or any such faculty which is included or would likely to be included by the University Act]

PROCEDURE FOR SUBMISSION OF ON-LINE APPLICATION FORM:

On-line application form is available on websites http://bedjammu.org, www.jucdc.in. After completing on-line application form, a print-out of the same be taken and application fee (non-refundable) be deposited through the challan generated by the system in any branch of the designated banks i.e. The Jammu & Kashmir Bank Ltd.; HDFC Bank, AXIS Bank all over the country. The fee can also be paid through e-banking/debit/credit card by exercising on-line payment option while completing the form. Non-deposit of application fee would render the application form cancelled.

ADMISSION PROCEDURE

Admission shall be made through on-line Counseling on the basis of academic merit of the qualifying examination (i.e. Bachelor's degree) and college choice/s given by the candidate in the application form. No Separate intimation for Counseling or admission shall be sent individually to the candidates. Candidates are advised to keep in constant touch with the above mentioned websites and also check their e-mail accounts).

TENTATIVE FEE STRUCTURE:

The fee for the first year is Rs. 33,970/- which a candidate has to deposit in the bank through the challan generated by the system at the time of downloading allotment letter or the same can be deposited through payment gateway. Besides this, candidates have to pay fee in their respective colleges as per details given under the heading "fee payable at college" in the information brochure.

IMPORTANT NOTES:-

- 1. NCTE Act is not applicable to the State of Jammu & Kashmir The University has, however, revised updated its curriculum as per the recommendations of Justice Verma Commission and guidelines of the University Grants Commission/National Curriculum Framework for Teacher Education, with certain changes especially with regard to eligibility for admission to the B.Ed. Course as notified vide notification No.F.Acd./I/17/15322-92 dated 08.01.2017.
- 2. All admissions shall be provisional till such time the same are verified/regularized by the University. No document/certificate shall be accepted by the College after the admission.
- 3. M.C. Khalsa College of Education is authorized to fill 50% of its sanctioned intake seats under Minority Quota. No other college or any individual or agency anywhere in the country is authorized to make admission of candidates to the B.Ed course on behalf of the University of Jammu. The candidates are advised not to fall prey of any tout. Admission shall be made strictly on the basis of Academic Merit of the candidates who have applied online for admission.
- 4. Candidates are required to go through the detailed statutes governing two year B.Ed. course which are available on the University Website and must ensure that they fulfill the eligibility criteria for admission to the said course before filling up the on-line application form. It is a full time regular course of two year duration and English is the medium of instructions where as Hindi & English both are the medium of taking examination in all papers, except in Modern Indian Languages where the medium of instructions and examination shall be the language concerned. Candidates must satisfy the minimum attendance requirement for appearing in a semester examination.
- **5.** Candidates holding Bachelor Degree of One sitting pattern or having obtained Degree from Study Centres/franchises of other Universities(except IGNOU) or have passed in the Bi-Annual/Supplementary Examination in the same academic year in which



admission is being sought are not eligible for admission to the B.Ed. Course. However, as notified by the University of Jammu vide notification No. F.Acd/III/13/9362-9521 dated 22.10.2013, degrees obtained by the candidates through study centres of Maulana Azad National Urdu University (MANUU) are recognized provided the study centres are functioning strictly under the control of the MANUU as per rules and regulations of the University/UGC.

6. If at any stage it is found that a candidate has managed admission on the basis of false/fabricated/invalid documents, besides cancelling his/her admission, the University may also initiate penal proceedings against such candidate.
